Pursuant to Rule 50(2)(a) and (b) of the ICSID Arbitration Rules, I hereby notify you that I have on this day, Tuesday, March 16, 2021, registered an Application for Revision of the Award rendered on July 12, 2019 in *Tethyan Copper Company Ltd. v. Islamic Republic of Pakistan* (ICSID Case No. ARB/12/1) (“the Award”).

Pursuant to Rule 51(1) of the ICSID Arbitration Rules, I am transmitting to each member of the original Tribunal a copy of the notice of registration, together with an electronic copy of the Application and its accompanying documentation. I am also requesting each member of the Tribunal to inform ICSID whether he is willing to take part in the consideration of the Application.

The Application for Revision contains a request for a stay of the enforcement of the Award, pursuant to Article 51(4) of the ICSID Convention. ICSID Arbitration Rule 54(2) provides that the Secretary-General shall, together with the notice of registration of the Application for Revision, inform

both parties of the provisional stay of the enforcement of the Award. Accordingly, I hereby notify you that the enforcement of the Award is provisionally stayed.
