Dear Members of the Tribunal,

Pursuant to paragraph 53 of Procedural Order No. 12 (PO 12), Canada seeks an extension of the 21-day timeline set out by the Tribunal for Canada to provide the Claimant with its proposed confidential designations to the Mesa Power videos.

In light of the burdensome nature of this confidentiality designation process, and the fact that Canada and Ontario have and will be focussed on the preparation of Canada's Rejoinder until May 26, Canada respectfully requests a total of 60 days from the date of PO 12 (May 6, 2021) to provide the Claimant with its proposed confidential designations to the Mesa Power videos. This would result in Canada providing the Claimant with its proposed confidentiality designations on **July 5, 2021**.
